ABOUT SMMT



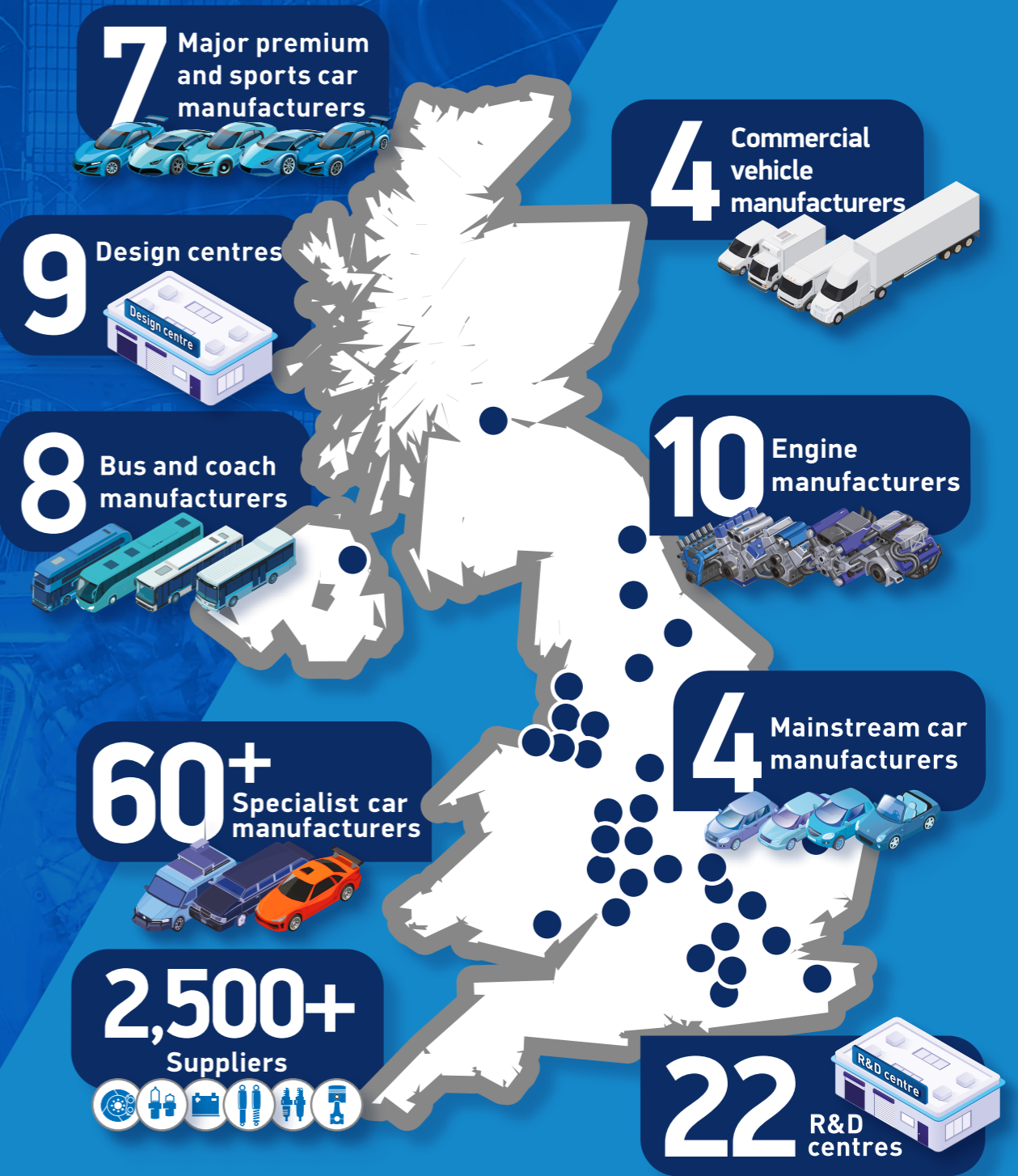

SMMT IATF Oversight is one of five IATF Oversight offices established by the International Automotive Task Force (IATF) to monitor and manage the 3rd party certification scheme for IATF 16949. Monitoring activities include frequent witness audits and office assessments world-wide. We work alongside other IATF Oversight offices to provide consistent guidance and interpretation in relation to the IATF 16949 standard and the certification scheme Rules. We also train and qualify 3rd party certification body auditors, support the development and maintenance of a central database of strategic information to assist in the management of the IATF 16949 certification scheme.



THE MOTOR OMBUDSMAN LTD

The Motor Ombudsman provides a self-regulatory environment for the UK's motor industry. As an independent and impartial organisation acting on behalf of consumers and its accredited businesses, it is responsible for resolving automotive-related disputes and raising the standard of service through its comprehensive Chartered Trading Standards Institute (CTSI)-approved Motor Industry Codes of Practice.
